It may be noted that consequently, re-appointment of the whole-time director, Rajnish Kumar Singh as Director (Plant) for a term of 3 years from 01 April 2020 to 31 March 2023, as approved by the Board of Directors in its meeting held on 14 February 2020, stands nullified and he will revert to his earlier position as Director (Corporate) as per the approval accorded by shareholders on earlier occasion vide resolution passed on 21 July 2018 and which is valid till 31 December 2020. Further, the appointments of Mubeen A. Sheriff and Sachin Sanu as directors on the Board and their appointments as whole-time directors also stand annulled and they revert to their earlier positions and continue in their respective capacities of Head-Commercial and Chief Financial Officer respectively.

The Holding Company Skand Private Limited has by letter dated 1 July 2020 informed the Company that considering the developments subsequent to the recommendation of aforementioned resolutions by the Board on 14 February 2020, i.e., probable impact of Covid-19 on the operations of the Company, relieving of Nazim Sheikh from the services of the Company due to his health reasons, stabilizing of operations consequent to commissioning of the projects etc., the Promoters are of the view that the Company should conserve the available resources and defer some of the elevations, to be considered at a later stage.

We request the Exchange to kindly take note of the above.
