अपनी डाक्यूमेंट्री 'काली' को लेकर उत्पन्न विवाद के बीच फिल्मकार लीना मणिमैकलाई ने गुरुवार को कहा कि वह 'इस समय कहीं भी' सुरक्षित महसूस नहीं करती हैं। 'काली' के पोस्टर में देवी को धूम्रपान करते और एलजीबीटीक्यू का झंडा पकड़े हुए दिखाए जाने के बाद फिल्मकार के खिलाफ कई जगहों पर मामला दर्ज किया गया है। मणिमैकलाई ने ब्रिटिश अखबार 'द गार्जियन' को टैग करते हुए और अखबारों पर विवाद के साक्षात्कार करते हुए लिखा, 'मैं इस समय कहीं भी सुरक्षित
